

Building Regulation Charges with effect from 2nd October 2017

Charges in respect of new dwellings, conversions to dwellings, domestic extensions & alterations and non-domestic work.

The following guidance notes and tables are designed to help you complete your Building Control Submission with CNC Building Control. There are two ways to apply for Building regulations, either via a Building Notice or through a Full Plan application.

A Full Plans Application requires the payment of the **Plan Charge (+ VAT)** at the same time as the application is submitted. A Full Plans application is not legally deposited until the payment is received. The applicant (unless advised otherwise) will be invoiced for the full **Inspection Charge (+ VAT)** after the first inspection has been carried out.

A Building Notice charge (+ VAT) is payable when a building notice is submitted. A building notice is not considered valid until payment (in full) is made.

These standard charges have been set by CNC Building Control on the basis that the building work does not consist of, or include, innovative or high risk construction techniques and/or the duration of the building work from commencement to completion does not exceed 12 months. The charges have also been set on the basis that the design and building work is undertaken by a person or company that is competent to carry out the work that they are undertaking.

If CNC considers it necessary to use a consultant to provide specialist advice in relation to a particular aspect, any associated costs may also be included in setting the charge.

The quotation/fee you receive from CNC Building Control will be based on the information provided by you at the time of application or enquiry. We will increase fees and ask for additional money where works differ from what was originally advised once we are on site or where extra inspections are undertaken over and above our original estimates.

If the building work which you are intending to carry out does not appear in these tables, the charge will be individually determined. Additionally, if you have already undertaken the works and are looking to make a retrospective application the charges will be individually determined by contacting the office and be dealt with as a Regularisation Application.

TABLE D**Non Domestic Work - Extensions and New Build (up to 200m²)**

Commercial extensions and new builds can vary greatly in their complexity and the involvement required by Building Control. Therefore, we would ask that you contact us so that we can give the most cost-effective price based on your individual project.

Typically, we use the categories of work listed below in terms of size – there are then other factors to consider such as the future use of the extension/building. For example, uses can range from industrial or storage through to educational, office or retail. Each of these will have varying differences on the amount of work involved from a Building Control perspective.

In order to be as accurate as possible, it would help us if you have the following information available when calling for a fee:

- Size of project (both in terms of area and no of storeys)
- Estimated construction costs of the project
- Anticipated build duration
- Whether the works are to be phased
